Note: Two public hearings are required for special exception requests. The first public hearing will be scheduled with the Planning Zoning Board on the first Thursday of the month at 5:30 p.m. The second public hearing will be scheduled with the Board of County Commissioners on the second Wednesday of the month at 9 a.m. or the fourth Wednesday of the month at 6 p.m. Completed application must be received in a timely manner to meet the advertising deadline. If a special exception is granted, a development review meeting will be scheduled, and a development permit is required before the applicant can proceed with development.
